
Captain **[REDACTED 0]**, a member of the Executive Board, requests a meeting with concerns regarding the proposed hiring of [REDACTED] as a business agent. No specific duties or responsibilities nor reason for the said business agent were posted in union impact.

- Although a significant financial commitment existed, no Executive Board meeting to which Captain [REDACTED 0] was invited to or a part of had previously discussed said hire or other motions in Union Impact of financial importance.
- Within 5 minutes of the motion to hire [REDACTED] being posted to the Union Impact software for a vote, a majority of the Executive Board members had already voted 'YES'.
- Captain [REDACTED 0] expressed his concerns to the remaining Executive Board that no meeting or reasonable discussion was held to discuss this and other "rapid fire" motions and requests a formal Executive Board meeting to discuss these financial commitments.
- Captain [REDACTED 1] claims all Bylaws requirements are met and no meeting is required, but will, as a "courtesy", "accommodate" [REDACTED 0]'s request by offering an *immediate* meeting via teleconference for "a few minutes".
- Captain [REDACTED 0] is unable to attend due the immediate notice of a "meeting" and suggests that such a manner of operation regarding voting, particularly with financial implications, is unreasonable and unethical.
- Captain [REDACTED 1] suggests that Captain [REDACTED 0] "has no idea what that word means" and suggests that his behavior/word usage is similar to a "child throwing a tantrum."




