Dear Brother Robles:

As you were informed by Airline Division Director Ferreira on October 19, 2023, the term of office for Teamsters Local Union No. 2118 ("Local 2118") ends on December 31, 2023 and Local 2118 is required to conduct and complete its officers election on or before December 31, 2023. Director Ferreira's communication to you was in response to your October 10, 2023, request that he confirm the term of the Local 2118 officers' term of office. Mr. Ferreira informed you that Article XX, Section 3(b) of the International Constitution states that:

When an election is held in connection with the release of a Local Union from Trusteeship, the terms of the officers elected shall commence as of the effective date the Local Union is formally released from Trusteeship by the General President and shall terminate on December 31 of the second full year thereafter, unless the Local Union may legally have a term of office of four or five years and the Local's Bylaws so provide. In such cases, the term of office shall terminate on the December 31, 2023, of the third or fourth full year following release from Trusteeship, whichever is applicable.

Local 2118 was released from Trusteeship and officers' term of office commenced effective January 1, 2022. As is clear from the above-quoted and emphasized language, the International Constitution mandates that the term of office of a local union's officers' position ends on December 31 of the second full year after the local union is released from trusteeship. The Local 2118 officers were duly elected in December 2021, and their term of office commenced effective January 1, 2022. The second full year of their term ends on December 31, 2023.

This office has continued to receive inquiries from members of Local 2118 regarding the conduct of the Local 2118 election. Those inquiries suggest that Local 2118 has not advised its members that the election of officers must be conducted and completed by December 31, 2023. The conduct of a local union election, at minimum, takes fifty (50) days. That means that if the process was started today, the Local would not be completed until mid-December 2023. In other words, time is of the essence. Local 2118's failure to timely initiate its officers election and the resulting compression of the election period raises concerns about the transparency of the election process and may invite significant election challenges.

You are directed to immediately issue a notice of nomination and election of Local 2118 officers. The notice must be posted, and it must be emailed and mailed (by regular mail) to every Local 2118 member. Local 2118 must certify to my office that the notice was posted, emailed and mailed to every Local 2118 member by the close of business, October 27, 2023. The election must be completed and certified by December 31, 2023. You are further directed to provide my office with an election plan containing election rules and election deadlines by November 3, 2023. I also strongly urge you to secure the services of a professional firm to supervise the Local 2118 election. Finally, I direct you to immediately send this letter to all members of the Executive Board.

I will await your acknowledgment of compliance with these directives.



- Our slate has heard from many Military Leave members that they have not received a ballot.
- One example is Paul Long 23098 who has not received a ballot. He has called Karen and she said for him to call GES to get a ballot mailed to him. When he calls GES, they say they can't mail him a ballot because he's not on the list that GES has. Please help rectify this problem for Paul Long.

#### **ANSWERS:**

GES is not sending emails to members other than responses to inquiries TO <a href="https://example.com">helpdesk@voteges.com</a>. The Notice of Nomination gave instructions on how a member is eligible to vote.

GES mailed ballots to members on the voter list provided to us by the International Union. Members who were not on the original mailing list that contacted the GES helpdesk were sent an add-on ballot upon authorization by the Local, which will be challenged and eligibility verified on tabulation day.

When the IBT provided Local 2118 with the database for the mailing of the Notice of Nominations and election, it included members who were in arrears and the Notice explained what is needed to be eligible to receive a ballot.

Members in good standing must have dues paid through November 2023. The members who are on check-off with the employer have a three-month grace period, according to the IBT Constitution. After three months the member must pay his/her dues directly to the Local.

When you review the weekly report, you will see the names of the members who were sent an add-on / challenged ballots. However, in order to be included in the count, the member must still be eligible to vote as outlined above. All challenged ballots will be verified before the envelopes are opened and tabulated.

If members are on disability, on leave or similar, they would have needed to apply for a withdrawal card AND they still need to pay their dues through the month of November 2023.

Below is the pertinent section from the Notice of Nomination and Election, which was also placed on the Local 2118 website:

"In order to vote in the election, a member must be in good standing and have paid his/her dues through November 2023. Members may pay all dues arrearages, initiation or reinstatement fees, at the Local 2118 office until 12 Noon on December 26, 2023."

As far as Paul Long, he was not on the original mailing list that was sent to us by the IBT. After he called for a ballot, our helpdesk reached out to the Local to authorize GES

to add him and send an add-on / challenged ballot. It was authorized and he was sent an add-on / challenged ballot. Jim from our helpdesk left him a voicemail with a confirmation number for his fulfilled request.

All helpdesk calls are documented and recorded. If the call is not resolved in the initial conversation, the inquiry is researched byour office and once all information is verified, the caller receives confirmation of their fulfilled request when appropriate.

Please note that the request period for duplicate ballots ends on **December 15 at 12:00 noon PST.** No new requests will be accepted via phone or email after that time.







Thanks for the video update today. I have several questions I would like a response to below.

It appears in your video update that you have broken the pilot group in to two groups;

Group 1, those that are considering leaving if we can't get a contract soon, which is mostly the junior pilots.

Group 2, those that have no plans to leave, which is mostly the senior pilots (approximately 500) your group.

You seem to be suggesting that Group 1 go ahead and leave, so the Union will have more leverage over the Company to get what Group 2 really wants.

#### Questions;

You stated you plan on filing with NMB very soon. Do you really think NMB would accept your request, even though the Union has not made passes in writing to the Company on 4-8 of the 26 sections? In my experience with mediation, this would never fly.

Again, I would like to suggest changing the format of the Tentative Agreement and Passes spreadsheet. I have attached my version for review. It would also be nice to post this document on the 2118 website vs just posting it on Facebook. This would be very informative for entire pilot group.

Can you please share with me what Attorney Firm and Attorneys were using to represent us in these negotiations?

What are your plans when the Majors slow hiring in the future, which will significantly hinder the Union's leverage for negotiations? FedEx has already slowed hiring because of slow down.

If the Company's comprehensive package pass is so bad, why don't you share that with the pilots? You would just need to amend the NDA with the Company and Union. If the Company thinks there comprehensive package is great, they should be okay with sharing it and if you think the Company's comprehensive package is bad, you should be okay sharing as well. This would create the necessary transparency to entire pilot group, before you embark on the long NMB process to maybe or maybe not get an agreed on CBA.

Why not get what you can now, while you have the most leverage and sign a 2 or 3 year CBA now, before we lose all or most of our leverage? Then, the Union would have less to work on in 2-3 years from now.

At the end of the day, negotiations is a give and take. Not all or nothing.



#### **Electing Local Union Officers by Mail**

This pamphlet has been developed by the Office of Labor-Management Standards (OLMS) to help election officials conduct union officer elections by mail in accordance with the requirements of the Labor-Management Reporting and Disclosure Act of 1959, as amended. Many unions conduct officer elections by mail because their members are dispersed over a wide geographic area making travel to polling sites difficult. In addition, some unions that conduct their elections at polling places also allow absentee voting by mail.

If questions arise about mail balloting procedures or other election requirements not covered in this pamphlet (such as nomination procedures, candidate eligibility, and campaign rights and restrictions), election officials should contact the union's parent body or one of the OLMS offices.

If your union conducts its election at a polling site, election officials should read the OLMS pamphlet <u>Checklist for Conducting Local Union Officer Elections</u> which is designed to serve as a reminder of the various tasks which should be completed during the nomination and election process.

#### Preparations

- Develop a time schedule for each step of the mail ballot election (ballot printing, mailing, return deadline, and counting) which allows adequate time for completing each phase. As a general rule, allow 3 to 4 weeks for members to mark and return their ballots.
- Establish a date and time by which voted ballots must be received in order to be counted and clearly announce this deadline in the
  voting instructions. Do not use a postmark date for the ballot return deadline date because a significant percentage of mail is not
  postmarked.
- Update the union's membership address list to insure that the address for each member is correct. Review the union's most recent mailing to all members to determine if any pieces of mail were returned undelivered, make a list of members for whom new addresses are needed, and attempt to obtain updated addresses for those members.
- Arrange with postal officials for a special restricted-access post office box to be used solely for the receipt and storage of voted ballots. Do not use the union's regular post office box or union office for the receipt of voted ballots. Instruct postal officials that ballots must be released only at a specified time on the ballot return deadline date and only to authorized union election officials.
- Arrange with postal officials for a second post office box for ballot packages returned undelivered. This post office box will serve as
  the return address on the ballot package mailed to members.




